

# Homebuyer Dream Program® (HDP®) Submission of an HDP® Funding Request

#### Tutorial on How to Submit an HDP Funding Request

In this tutorial we will provide an overview on how to complete the HDP, HDP Plus and HDP Wealth Builder Funding Request, as well as how to submit the completed HDP Funding Request via the Federal Home Loan Bank of New York's File Transfer System (FTS).

# SUBMISSION VIA A FILE TRANSFER SYSTEM

Pursuant to applicable Federal and State laws, to protect household information that may be utilized to develop a credit profile if intercepted by an unauthorized third party, the FHLBNY requires that all HDP documentation be submitted through the FHLBNY's File Transfer System (FTS).

File Transfer System (FTS)

- The FHLBNY requires reimbursement of funds to the member to occur by the household's 120-day commitment expiration.
- Funding requests must be submitted by the member to the FHLBNY upon receipt of closing documentation and no later than fifteen (15) days prior to commitment expiration.
- All documentation is reviewed for eligibility, consistency and accuracy as to the household closing.
- If applicable, the FHLBNY will email the member for additional details.
- The FHLBNY will reimburse the member on a post closing basis.
- Grant funds are disbursed to the member's Overnight Investment Account with the FHLBNY.
- An email will be sent to the member to confirm the funding of the HDP grant.
- The member is responsible for the issuance (or recordation) of a subordinate lien for the HDP grant.





The member is responsible for ensuring HDP retention documents are fully executed at the time of closing.

Retention documents can be found with all HDP Forms & Agreements.

Note: Retention documents are not required for HDP Plus & HDP Wealth Builder.



#### HDP Funding Request Package - FHLBNY Retention Documents

- Fully executed FHLBNY retention documents must be provided within the HDP Funding Request
- Retention documents are fillable PDF forms
- No alterations may be made to the retention documentation
- The Subordinate Mortgage or Declaration of Restrictive Covenant must be signed by all individuals listed on the title to the subject property

  - FHA Retention (HDP-006 FHA)
- ✓ Co-Op Financing

## HDP Funding Request Package - Closing Disclosure



The Closing Disclosure must demonstrate the following:

- The total grant amount must be itemized as follows:
  - "Homebuyer Dream Program" or "HDP"
  - "Homebuyer Dream Program Plus" or "HDP Plus"
  - "Homebuyer Dream Program Wealth Builder" or "HDP Wealth Builder"
- The non-profit counseling agency fee, if applicable, must be itemized on the Closing Disclosure
- The household's minimum equity contribution of \$1,000 used towards down payment, closing costs or costs paid before closing for the purchase of the property must be clearly identified
- Participating members may provide cash back to a household at closing in an amount not exceeding \$250. A member shall use AHP direct subsidy exceeding such amount as a credit to reduce the principal of the mortgage loan or as a credit toward the household's monthly payments on the mortgage loan. HDP grant funds cannot be used to reimburse household for earnest deposits or cash down payments.



The HDP-005 Request Form is a Microsoft Excelbased document that can accommodate six (6) different request types, depending on the selection:

- Homebuyer Dream Program®
- Homebuyer Dream Program<sup>®</sup> Plus
- Homebuyer Dream Program® Wealth Builder
  - New Household Reservation Request
  - Funding Request
  - Other Documentation Request



Select the [Funding Request] option, then the [Initiate Funding Request] button to begin.

Once a request type has been selected and initiated, there is no opportunity to change the request type or start over. In this event, a new copy of the form can be downloaded from the FHLBNY website, or close and reopen the downloaded form.

File Transfer System (FTS)

- A status bar is located at the top of the form to assist as you complete each required section.
- The HDP Request Form must be 100% completed prior to submission to the FHLBNY.
- Each Section has a Field Symbol indicating whether the section is Required for completion, has been completed with a Valid Entry or contains an Invalid Entry. A Field Symbol Legend indicates the meaning of each symbol.
- Incomplete sections within the HDP Request Form submission will result in delays during processing. For ease of use, a hyperlinked table of contents is provided at the top of the form to assist the user during navigation.
- The table of contents includes progress indicators which are updated in real time as you complete the form.
- The progress indicators confirm which sections are completed as well as those sections which require attention.



The member representative executing the HDP Request Form is one of the designated users authorized to submit household files via the FHLBNY's FTS.

Submissions by unauthorized users will be denied.



## Submission of the Funding Request

Overview

File Transfer System (FTS)

- Household files are submitted to the FHLBNY as one zip file per household.
- The user must submit an HDP Request Form (in MS Excel format, containing the .xlsx file extension).
- Supporting documentation must be included within the zip file in clear and legible PDF format.
- Once all the required documents have been saved in one zip file per household, the user is ready to submit the file to the FHLBNY via our FTS.






Navigate to the section to submit your HDP Request.

• The [SUBMIT YOUR HDP REQUEST] button brings you directly to the FHLBNY's FTS login screen.




#### Logging into the FTS

- Only authorized users can access the FHLBNY FTS and upload zipped household files to the FHLBNY via Multi-Factor Authentication (MFA).
- Enter the user credentials provided by the FHLBNY to enter the FTS.




#### Logging into the FTS

- You will be asked to enter a one-time passcode sent via email from <u>noreply-FTS@fhlbny.com</u> to the address you supplied when you enrolled in the FHLBNY FTS.
- If you do not see the e-mail, check your spam folder and ensure the email address, <u>noreply-FTS@fhlbny.com</u>, is whitelisted.
- Passwords assigned to authorized users can not be personalized. If you forget your password, please email us at <a href="https://html.ncom">https://html.ncom</a> and we will resend your password to the authorized user on file.




#### Logging into the FTS

• Enter the one-time passcode from your email and select **Submit**.




 Upon successful verification, you will be able to access the FHLBNY FTS.



#### Uploading your HDP Request

- To upload a file, select the [**Upload**] icon at the top of the screen.
- Locate the zipped household file and select [Open] to upload the file to the FTS.



- The uploaded zip file will appear within the landing page of the FTS under the "In-Progress" section.
- This section will indicate to the user that the file upload was successful.
- An automatic email message is also sent to the member confirming a successful file submission.



Note: The submission of a new household reservation request through the FTS does not constitute a reservation or commitment of funds.



- If additional documentation is requested by the FHLBNY, the member is required to submit an HDP Request Form (in MS Excel format, containing the .xlsx file extension) by selecting the [**Other Documentation**] form request type.
- The HDP Request Form, along with the requested documentation (in PDF format), must be submitted via the FTS as one zip file per household.




